- The main problem is paying the bills. I will forward you the ones from Draper. We have other bills that have also come through that I think I forwarded to you about the lights.
- They want money so they can go forward and continue to do the lights and do the repairs. . We have a checkbook with one signature of mine (Paul Tonks). I am happy to go through and do that but I have to figure out and transfer the TIFF funds into the Wells Fargo account.
- With that I will have to get with Cal. Cal did it before. But for a long-term solution it would be nice to have a treasurer.
- There is certain training involved with the auditor. The new funds from the Salt Lake County are being held. Because the auditor says we have not complied with his requirements.
- So, once we get a treasurer they can go ahead and take the test and get the requirements done.
 So, they can release the money. It is only about \$100,000. It's with Salt Lake County that it needs to be transferred over. Most of our money, 1.6 million or so is in the TIFF account. So that is not a problem, we can pay all our bills with that.
- Any thoughts on how we can go forward on it, I am happy to give it over to the treasurer to have him take it over with Cal. Because Cal knows how to do it. Or I can pay the bills that are done right now. Then the treasurer can get up to speed with Cal then can take care of it from now on.
- Paul Tonks make a motion for Simon Cantarero as the new treasurer, Simon seconds Dave approves. Simon will reach out to Cal and find out what he needs to do with the auditor. Hopefully, Cal will give Simon the software he purchased so Simon can use it.
- We will get rid of all of the city lights then replace them with lights that match Suncrest better.
- Only one person has applied for the new spot on the TRSSD board. Benjamin is still planning to be on the board; he is just on military leave. He will be back in July and will be back to normal.
